Required:

- 2016 tax return (if available).
- Valid picture identification.
- Social security card or Individual Taxpayer Identification Number (ITIN) for each taxpayer(s), family member and working adult.
- All income statements, such as 2017 W-2s, 1098, 1099 forms for you and spouse.
- Any forms 1095 - proof of health insurance.

If Applicable:

- Proof of other income for you or spouse.
- Form 1098T and education expenses for students.
- Childcare provider name, address and tax ID.
- Property tax & interest information, if homeowner.
- Bank routing and account numbers for checking or savings account.
